PUBLIC NOTICE

LEVY AND COLLECTION OF 2022-2023 REAL PROPERTY TAXES

BE IT RESOLVED that, pursuant to § 1420, New York State Real Property Tax Law, Steven W. Brautigam, Clerk/Treasurer, and

Tax Collector, is hereby directed to receive and collect from all persons named in the tax roll hereunto annexed, the several sums stated in the last column hereof opposite their respective names, for the following purposes:

For the General Fund:	\$3,972,645.00
For the Water Fund:	251,955.00
For the Sewer Fund:	288,745.00
For the Annual Water Usage:	252,320.00
For the Annual Sewer Rent:	495,520.00
For the Water System Debt Service:	243,473.00
For the Excess Water: Usage	27,000.00
For the Excess Sewer: Usage	52,500.00
For the Refuse:	<u>491,400.00</u>
Being for all purposes a total amount of:	\$5,943,542.00

Be it further RESOLVED that, Steven W. Brautigam, is hereby directed to receive and collect full year taxes without additional charges between the first day of June and the first day of July, 2022. On all such taxes remaining unpaid after July 1st through July 31st, 2022, interest of five percent, and one percent per month shall be added for the months thereafter until paid.

Be it further RESOLVED that, pursuant to § 1426, New York State Real Property Tax Law, the execution of the Warrant for Collection of Real Property Taxes, by James S. Mallott, Mayor, and attested to by Steven W. Brautigam, shall hereby be authorized and ratified.

Be it further RESOLVED that, Steven W. Brautigam, is hereby directed to file the tax roll and warrant in his office on or before the first day of June, 2022, and make it available to the Board of Trustees at the same time, an account of the Taxes remaining due and unpaid, showing the person or persons to whom the parcel is assessed and showing as to each parcel the amount of tax unpaid.
