The validity of the obligations authorized by such resolution may be hereafter contested only if such obligations were authorized for an object or purpose for which the Village of Ocean Beach, in the County of Suffolk, New York, is not authorized to expend money or if the provisions of law which should have been complied with as of the date of publication of this notice were not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of publication of the notice, or such obligations were authorized in violation of the provisions of the constitution.

**BOND RESOLUTION OF THE VILLAGE OF OCEAN BEACH, NEW YORK, ADOPTED APRIL 9, 2016 AND AMENDED JULY 24, 2023, AUTHORIZING THE ISSUANCE OF BONDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$14,500,000 TO FINANCE THE CONSTRUCTION OF IMPROVEMENTS TO THE VILLAGE'S SEWER COLLECTION SYSTEM, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$14,500,000 AND APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE**

The object or purpose for which the bond are authorized is the construction of improvements to the Village's sewer collection system, including replacement of existing sewer lines and installation of a new stormwater collection system, at the estimated maximum cost of \$14,500,000.

The amount of obligations to be issued is \$12,500,000.

The period of probable usefulness is forty (40) years.

A complete copy of the bond resolution summarized above shall be available for public inspection during normal business hours at the office of the Village Clerk, at the Village Hall, Bay and Cottage Walks, Ocean Beach, New York.
