### **NOTICE OF TAX SALE FOR UNPAID TAXES** **INC. VILLAGE OF OCEAN BEACH**

PLEASE TAKE NOTICE that pursuant to a Resolution of the Board of Trustees of the Incorporated Village of Ocean Beach, County of Suffolk, and State of New York, passed at a meeting thereof held on the 11th day of January, 2020, the undersigned Clerk/Treasurer of the said Incorporated Village of Ocean Beach will sell at public auction, in the manner provided by law, on the 6th day of March, 2020 at 1:00 o'clock in the afternoon of that day and on succeeding days, at the Office of the Treasurer of the Incorporated Village of Ocean Beach in the Village Office at Cottage and Bay Walk in the Village of Ocean Beach, New York, so much of each of the following parcels of real estate upon which Village taxes remain unpaid as will be sufficient to discharge the tax, interest and charges thereon, which may be due at the time of sale.

Each purchaser at such tax sale may pay the amount of his bid to the Village Treasurer within ten (10) days of the sale, and upon such payment, the Treasurer shall give to the purchase a certificate in writing describing the real property purchased and the sum paid therefore.
