SUMMER CART RULES AND RESTRICTIONS **FOR JUNE 15TH – SEPT. 15, 2016** **NO DRIVING ON BAY WALK ANYTIME** **NO DRIVING SATURDAY & SUNDAY**

CART USE DURING THE FOLLOWING HOURS ONLY:

- 5:00AM – 8:30AM
 - 11:00 AM – 12:00 NOON (1 hr. before Freight)
 - 1:00 PM – 2:00 PM (1 hr. after Freight)
 - 3:30 PM – 7:30 PM

- 5 MPH SPEED WILL BE STRICTLY ENFORCED.
 - DRIVERS MUST COME TO A COMPLETE STOP AT ALL NORTH/SOUTH INTERSECTIONS.
 - NO DRIVING ON BAY WALK FROM BAYBERRY WALK TO OCEAN ROAD AND FROM OCEAN BREEZE WALK TO SURFVIEW WALK.
 - FREIGHT ACCESS FROM OCEAN BREEZE AND BAYBERRY WALK ONLY. NORTH ON BAYBERRY – SOUTH ON OCEAN BREEZE (DURING FREIGHT TIME).
 - FAILURE TO OBEY RULES AND RESTRICTIONS WILL RESULT IN A FORFEITURE OF PERMIT WITH NO REFUND.
