TENNIS RULES, REGULATIONS & RATES

Weekend players will have to give up **one hour** each on a Saturday and Sunday in late August for the Annual OB Tennis Invitational Tournament, which started in 2004 with great success.

1. Rates: All rates quoted are per court, whether two (2) or four (4) players.
2. Season: The season is a calendar year, when courts are opened in the Spring and closed in the Winter (April through November of each year, exact dates varying).
3. Times: Court open from 8AM – 10PM.
4. Resident/Renter & Non-Resident Players: Foursome: At least three (3) residents
 Twosome: One (1) resident
5. Classification of Permits: Season Permits – full season
 Monthly Permits – half the rate of full season –available only if no season permit is issued for that day and time.
 Hourly Court Time: assigned on a first come, first served basis.
6. Seasonal Permit Players: When such a permit is issued to a foursome, at least one member of the registered group, must play. Others may be invited to fill in a foursome.
