- Please take notice: Completed Marina Slip Rental Applications are due no later than **February 15, 2019** for renewals, and **March 15, 2019** for renter, and out-of-village, Fire Island Resident, with all the necessary enclosures. **If you are late, you will lose the opportunity to keep the same slip.**
- 25% late fees will apply for late applications.
- **The Marina will be open from April 15, 2019 through November 15, 2019.**

DOCKING REQUIREMENTS:

1. Marina Docking Permit must be displayed and visible from the dock.
2. Must use a minimum, of ½" line.
3. Spring lines are required for all boats.
4. All boats must be registered and insured in the applicant's name.
5. No items are to be mounted to bulkhead, poles or dock.
6. Docks must be kept clear of all personal items, i.e.: carpets, wagons, boxes, etc. or they will be removed.
7. Rules and Regulations may be found in Village Code Chapter A168.

GENERAL REQUIREMENTS:

1. Ocean Beach Renter applicants must provide a copy of an executed lease to validate a 2019 Marina Application.
2. Out-of-Village applicants must provide a copy of proof of Fire Island residency (i.e.: current tax bill or Utilities bill.)
