VILLAGE OF OCEAN BEACH CREDIT CARD POLICY

The following policy has been established by the Village of Ocean Beach Board of Trustees regarding Issue and Usage of Village credit cards:

- 1. Only the Board of Trustees shall authorize the issuance of Village credit cards to Village employees. The sole purpose of the Village issuing credit cards is to provide authorized employees of the Village with a convenient method of payment for Village related business expenses.
- 2. Only authorized expenditures, as deemed appropriate by Village policy, may be placed on a Village credit card.
- 3. Village credit cards shall never be utilized for personal purchases or expenses.
- 4. The Village Clerk and Village Mayor must be notified immediately of any loss of a Village credit card so that appropriate action can be taken to cancel the card (and reissue a new card, if deemed appropriate).
- 5. The Village Clerk and Superintendent of Public Works (and/or their designees) are authorized to use Village credit cards to purchase supplies/material and to make reservations for conferences/seminars that have been approved by the Village Board of Trustees.
- 6. No one is authorized to utilize "Cash Advance" with any Village credit card at any time.
- 7. The Village Mayor has the right to revoke any Village credit card at any time. Upon request to the card holder by the Mayor (or his designee), a Village credit card must be immediately returned to the Village.
- 8. Any unauthorized expenditures made on a Village credit card shall be the sole responsibility of the cardholder. The cardholder shall immediately make full payment to the Village. Additionally, the cardholder may be subject to appropriate disciplinary proceedings.
- 9. When a Village credit card is used, the employee making the purchase shall sign the credit card receipt and submit same to their immediate supervisor with appropriate paperwork documenting the authorization to make such purchase.
- 10. Supervisors shall verify that each use of a Village credit card is appropriate and properly documented. On a monthly basis, supervisors shall sign-off on monthly credit card bills and submit all documentation pertaining to Village credit card usage to the Village.
- 11. Purchase of fuel. If a Village credit card is used to purchase fuel, the Village vehicle description, license plate number and current mileage must be printed on the face of the original credit card receipt. If the fuel is being dispensed to a gas can (for use with Village equipment), the Village equipment and department must be printed on the face of the original credit card receipt.
- 12. Failure to comply with this policy or failure to provide the necessary documentation may result in the expenditure being "disallowed". In the event that an expenditure is "disallowed", the unauthorized expenditures shall be the sole responsibility of the cardholder.

The cardholder shall immediately make full payment to the Village. Additionally, the cardholder may be subject to appropriate disciplinary proceedings.

13. All employees that are issued a Village credit card or are authorized to use a Village credit card shall sign and acknowledge this policy.
